Pursuant to section 252(e) of the Telecommunications Act of 1996, BellSouth and Essex Communications, Inc. d/b/a eLEC Communications are submitting to the Florida Public Service Commission an amendment to their negotiated agreement for the interconnection of their networks, the unbundling of specific network elements offered by BellSouth and the resale of BellSouth's telecommunications services to Essex Communications, Inc. d/b/a eLEC Communications. The initial agreement between the companies was filed in Docket 020441-TP, on May 16, 2002, and was will be deemed effective by operation of law on August 16, 2002

Pursuant to section 252(e) of the Act, the Commission is charged with approving or rejecting this amendment to the negotiated agreement between BellSouth and Essex Communications, Inc. d/b/a eLEC Communications within 90 days of its submission. The Act provides that the Commission may only reject such an agreement if it finds that the agreement or any portion of the agreement discriminates against a telecommunications carrier not a party to the agreement or the implementation of the agreement or any portion of the agreement is not consistent with the public interest, convenience and necessity. Both parties agree that neither of these reasons exists as to the agreement they have negotiated and therefore, as such this amendment should be deemed effective by operation of law on September 14, 2002.
