

SUPPLEMENTAL AFFIDAVIT OF W. KEITH MILNER
ON BEHALF OF BELL SOUTH TELECOMMUNICATIONS, INC.
JUNE 14, 2002

W. Keith Milner, being duly sworn, deposes and says:

1. My name is W. Keith Milner. My business address is 675 West Peachtree Street, Atlanta, Georgia 30375. I am Assistant Vice President - Interconnection Operations for BellSouth Telecommunications, Inc. ("BellSouth"). The purpose of this affidavit is to provide the Commission with the most current information concerning unbundled network elements, interconnection services, and resold services furnished by BellSouth.

Checklist Item No. 1 (Interconnection)

2. As of April 30, 2002, BellSouth had provisioned 152,626 trunks interconnecting its network with the networks of Alternate Local Exchange Carriers ("ALECs") in Florida (that is, trunks from ALECs' switches to BellSouth's switches). In its nine-state region, BellSouth had installed 486,724 trunks from ALECs' switches to BellSouth's switches as of that same date. As of April 30, 2002, BellSouth had

provided 287,304 two-way trunks (including transit trunks) to a total of 101 ALECs across BellSouth's nine-state region. In Florida, BellSouth has provided 81,728 two-way trunks (including transit trunks) to 48 ALECs.

3. In Florida, as of April 30, 2002, BellSouth had completed 1,257 physical collocation arrangements, of which 760 were cageless physical collocation arrangements for over 50 different ALECs. In addition, there were two (2) cageless physical collocation arrangements in progress for two (2) ALECs. Physical collocation arrangements were established in 130 different central offices out of a total of 211 central offices, including remote switches, in Florida as of April 30, 2002. As of April 30, 2002, there were 3,862 physical collocation arrangements in place for ALECs throughout BellSouth's nine-state region. Of these, 2,494 were cageless physical collocation arrangements. An additional 21 physical collocation arrangements were in progress for over 13 different ALECs as of April 30, 2002.
4. In Florida, as of April 30, 2002, there were 164 virtual collocation arrangements in service located in 75 different BellSouth central offices in Florida. As of that same date there were no virtual collocation arrangements in progress. Across BellSouth's nine-state region, over 40 different ALECs have requested and BellSouth had provided 426 virtual collocation arrangements with construction of an additional 12 arrangements underway as of April 30, 2001.

Checklist Item No. 2 (Unbundled Network Elements)

5. As of April 30, 2002, BellSouth had 305,621 loop plus port combinations in place for ALECs in Florida and 892,777 such combinations in place for ALECs across BellSouth's nine-state region. In addition, BellSouth had 2,613 loop plus transport combinations in place for ALECs in Florida as of April 30, 2002.
6. As of April 30, 2002, BellSouth had provided over 200 access terminals to ALECs in its nine-state region for the purpose of gaining access to sub-loop elements, of which over 50 were in Florida. Of those 50 access terminals deployed in Florida, they provide over 2,000 pairs available to the ALEC community.

Checklist Item No. 3 (Poles, Ducts, Conduits, and Rights-of-Way)

7. As of June 4, 2002, ALECs in Florida had executed with BellSouth 61 license agreements and 501 license agreements region-wide, (both state-specific and multi-state) which allow them to attach their facilities to BellSouth's poles and to place their facilities in BellSouth's ducts and conduits. Since July 1997, BellSouth has received and processed 380 requests in Florida for access to poles, ducts, conduits, and rights-of-way from 25 ALECs with no requests being denied.

Checklist Item No. 4 (Loops)

8. As of April 30, 2002, in Florida, BellSouth had provisioned 176,511 unbundled loops to over 40 ALECs, which includes 5,138 two-wire Asymmetrical Digital Subscriber Line ("ADSL") loops, 124 two-wire High Bit Rate Digital Subscriber Line ("HDSL") loops, and 41 four-wire HDSL loops to over 15 different ALECs. As of the same date, BellSouth had provisioned within its region 425,331 unbundled loops to ALECs, which includes 17,120 two-wire ADSL loops, 459

two-wire HDSL loops, and 60 four-wire HDSL loops.

9. In addition, ALECs in Florida have purchased and BellSouth has provided 568 unbundled sub-loop elements as of April 30, 2002.
10. BellSouth has provided 18 dark fiber arrangements in Florida. BellSouth has provided six (6) dark fiber arrangements in another state within BellSouth's nine-state region.
11. As of April 30, 2001, BellSouth had provisioned 7,900 line sharing arrangements across BellSouth's nine-state region and 2,312 line sharing arrangements in Florida.
12. From January 2001 through March 2002, ALECs made 75,758 mechanized Loop Makeup ("LMU") inquiries region-wide. In Florida, ALECs made 24,741 mechanized LMU inquiries. From November 2000 through March 2002, ALECs made 2,366 manual LMU inquiries region-wide, of which 1,031 were in Florida.

Checklist Item No. 5 (Transport)

13. As of April 30, 2002, BellSouth had provided 3,506 dedicated local transport trunks to ALECs in Florida. BellSouth has provided 11,787 such trunks to ALECs in its nine-state region as of that same date.

Checklist Item No. 6 (Switching)

14. As of April 30, 2002, BellSouth had 102 unbundled switch ports in service in Florida. Region-wide, BellSouth had 263 unbundled switch ports in service as of that same date. Additionally, in connection with its combined loop plus port combination offering, BellSouth had 305,621 switch ports in service in Florida and 892,777 in service regionally. BellSouth offers two methods of customized routing to ALECs: Advanced Intelligent Network ("AIN") and Line Class Codes ("LCC"). BellSouth has tested both methods and both currently are available.

15. To date, no ALEC has requested BellSouth's AIN method of customized routing. BellSouth stands ready to provide the AIN method upon request. BellSouth has provided the LCC method of customized routing to one (1) ALEC in Florida for its testing of this functionality.

Checklist Item No. 7 (911 and E911, Directory Assistance and Operator Services

16. As of April 30, 2002, ALECs had requested and BellSouth had provided 1,218 E911 trunks for ALECs in Florida. In its nine-state region, BellSouth had 5,113 trunks in service connecting ALECs' switches with BellSouth's E911 arrangements as of that same date. In Florida, 39 ALECs were sending mechanized updates to BellSouth for inclusion in the 911 database as of April 30, 2002; across BellSouth's nine-state region, 67 ALECs were doing so as of that same date.
17. As of April 30, 2002, ALECs in Florida had 1,036 directory assistance trunks in place between those ALECs' switches and BellSouth's Directory Assistance ("DA") platform. In BellSouth's nine-state region, there were 2,953 such directory assistance trunks in place serving ALECs. In BellSouth's nine-state region, 38 ALECs were purchasing Directory Assistance Access Service ("DAAS") and 32 ALECs were purchasing Directory Assistance Call Completion ("DACC") service from BellSouth as of April 30, 2002.
18. As of April 30, 2002, six (6) service providers were using BellSouth's Florida subscriber listings, via Directory Assistance Database Service ("DADS"), to provide DA service and third party listing data to end users. Nine (9) service providers were using DADS across BellSouth's nine-state region as of that same date. As of April 30, 2002, two (2) service providers in the region were using

Direct Access to Directory Assistance Services (“DADAS”) to provide the service to ALECs.

19. As of April 30, 2002, BellSouth had provided ALECs in Florida with 1,077 operator services trunks. Across its nine-state region, BellSouth had provided ALECs with 3,083 operator services trunks as of that same date. In Florida, BellSouth had provided ALECs with 139 verification trunks as of April 30, 2002. Across its nine-state region, BellSouth had provided ALECs with 462 verification trunks as of that same date.
20. BellSouth offers four (4) service levels of branding to ALECs when ALECs order Directory Assistance and/or Operator Call Processing. The options are: BellSouth branded; unbranded; custom branded; and self-branded. Unbranded, custom branded, and self-branded are all provided via customized routing.
21. An alternative to customized routing is Originating Line Number Screening (“OLNS”). OLNS permits ALEC OS/DA access over common end office trunks and provides BellSouth branded, unbranded, and custom branded call treatment. BellSouth completed its deployment of OLNS in Florida on June 19, 2001. Currently, there are four (4) ALECs in Florida using OLNS for OS/DA services.

Checklist Item No. 8 (White Page Listings)

22. BellSouth has long made its white pages listing capabilities available to independent LECs and other service providers. Because methods and procedures have been in place to allow other carriers access to BellSouth's white pages listing capabilities for many years, the necessary methods and procedures pursuant to which ALECs may obtain such listings are business as usual for BellSouth.

Checklist Item No. 9 (Numbering Administration)

23. At this time, BellSouth no longer performs the central office code assignment function. NeuStar assumed all North American Numbering Plan Administrator ("NANPA") responsibilities on November 17, 1999, when the FCC approved the transfer of Lockheed-Martin's Communication Industry Service division to NeuStar.
24. As to its responsibilities, BellSouth has responded to ALEC concerns about accurate and timely activation of central office codes ("NXX codes") by establishing, effective May 15, 1998, its NXX activation Single Point of Contact ("SPOC") to provide assistance to ALECs and independent LECs. The NXX SPOC processes requests for NXX code activity coordination, and provides information concerning BellSouth's architecture arrangements, assistance in trouble resolution for code activation, and assistance in preparing the NXX Code Request. If an ALEC or independent LEC intends to interconnect directly with BellSouth, or if interconnection arrangements with BellSouth are already in place, the ALEC or independent LEC should send to BellSouth a courtesy copy of its Central Office Code Request in conjunction with the submission of its Central Office Code Request to the NANPA (NeuStar). If the ALEC gives BellSouth a copy of its Central Office Code Request, BellSouth is better able to activate the Central Office Code in BellSouth's network.

Checklist No. 10 (Database and Signaling)

25. BellSouth's signaling service is available as evidenced by the fact that, as of April 30, 2002, there were 17 ALECs that had directly connected to BellSouth's signaling network in Florida.
26. BellSouth's region-wide Line Information Database ("LIDB") processed more

than 1.8 billion queries from ALECs and others during the period from January 1997 through April 2002.

27. As of April 30, 2002, BellSouth had over 100 Calling Name ("CNAM") database customers, consisting of both ALEC and independent LECs, across BellSouth's nine-state region.
28. BellSouth has offered independent LECs and other service providers access to its Toll Free Number database for years. The necessary methods and procedures for obtaining such access by ALECs are business as usual for BellSouth. Moreover, the availability of these services is evidenced by the fact that, from January 1997 through April 30, 2002, ALECs and other service providers across BellSouth's nine-state region completed over 18 billion queries to BellSouth's Toll Free Number database.

Checklist Item No. 11 (Number Portability)

29. BellSouth ported 19,971 lines in Florida using Interim Number Portability ("INP"). As of April 30, 2002, however, BellSouth had converted 19,393 (97%) of those lines to Local Number Portability ("LNP"). In its region, BellSouth ported 117,010 numbers, of which 110,677 (95%) have been converted to LNP as of that same date.
30. As of April 30, 2002, BellSouth had ported 499,592 business directory numbers and 80,159 residence directory numbers in Florida using LNP. In its nine-state region, BellSouth has ported 1,828,484 business and 211,242 residence directory numbers as of April 30, 2002, which confirms the availability of LNP.

Checklist Item No. 12 (Local Dialing Parity)

31. BellSouth's interconnection arrangements do not require any ALEC to use access codes or additional digits to complete local calls to BellSouth customers.

Neither are BellSouth customers required to dial any access codes or additional digits to complete local calls to the customers of any ALEC.

32. While BellSouth is unable to determine the full extent of ALEC dialing policies, BellSouth is not aware of any complaints from ALEC customers that they are required to dial any access codes or additional digits to complete local calls.

Checklist Item No. 13 (Reciprocal Compensation)


33. Reciprocal compensation arrangements are provided for in BellSouth's interconnection agreements as well as through its Statement of Generally Available Terms and Conditions ("SGAT").

Checklist Item No. 14 (Resale)

34. ALECs are reselling significant quantities of BellSouth's retail communications services. As of April 30, 2002, there were over 90 competing carriers with over 40 lines reselling local services to 146,120 customer lines in Florida. Throughout BellSouth's nine-state region, there were over 220 competing carriers with over 40 lines reselling local services to over 550,000 customer lines as of that same date.
35. This concludes my affidavit.
