Re: Notification of the Transfer of Ownership of New Century Telecom, Inc. and Request for Approval

Dear Ladies and Gentlemen:

New Century Telecom, Inc. ("NCT"), by its attorneys, hereby notifies the Commission of the transfer of control of the company. On February 13, 2002, NCT notified the Commission of the anticipated transfer of control to Alba Cipriani. On May 21, 2002, NCT notified the Commission by letter that transfer to Ms. Cipriani did not go through but that a new purchaser had been identified. By this letter, NCT hereby notifies the Commission of the new purchaser and requests Commission approval of the impending transfer.

On or about August 1, 2002, 100% of the issued and outstanding stock of NCT shall be transferred to Karyn Bartell. The company will continue to operate under the NCT name and to provide the same telecommunications services pursuant to the tariffs it currently has on file, except as they may be revised by appropriate filings as needed to provide new or additional rate plans.

Since customers pre-subscribed to NCT will not have their preferred interexchange carrier changed upon the transfer of ownership and assets, it is not necessary for the parties to obtain authorization and verification from each subscriber. Nor is it necessary for the Commission to impose any customer notification requirements. All customers will continue to receive service through NCT, all customer billing statements will continue to reflect the NCT name, customer service calls will continue to be handled by NCT representatives and all other interactions between the carrier and the customers will continue to be conducted through and under the name of NCT. Therefore, upon the transfer of control, customers currently pre-subscribed to NCT would not notice or experience any difference in service.


