RE: Request for Permission from Comptroller's Office to Write-Off the RAFs for the year 2002 for Easton Telecom Services Inc. (TI350 and TX107).

By Order No. PSC-02-0717-PAA-TP, issued on May 24, 2002, the Commission approved the cancellation of Easton Telecom Services Inc.'s Interexchange Telecommunications Certificate No. 3989 and Alternative Local Exchange Telecommunications Certificate No. 5187 due to bankruptcy. The Commission further ordered that the outstanding Regulatory Assessment Fees not be sent to the Comptroller's Office for collection, but instead, that the Division of the Commission Clerk and Administrative Services should request permission to write-off the uncollectible amount.

Therefore, staff requests that Bureau of Administrative Services/Fiscal Services Section take the appropriate steps to seek permission from the Comptroller's Office to write-off the uncollectible RAFs for the year 2002 for TI350 and TX107, and statutory penalties and interest charges for the years 1997 and 2000 for TI350.
