RE: Docket 020000, ATT Claim for Confidential Classification for Certain Staff Working Papers Obtained During Audit No. 01-268-3-1, Concerning Customer Complaints -- Documents 04983-02 and 05762-02

On April 17, 2002, staff held an initial audit exit conference with ATT regarding Audit No. 01-268-3-1 entitled "Investigation of Consumer Complaints and Company Compliance with Order No. PSC-99-0433-AS-TI, Issued March 3, 1999." At this exit conference, ATT requested that certain working papers be held as temporarily confidential in accordance with Rule 22.006(3)(a)(2), Florida Administrative Code (FAC).

On May 6, 2002, the audit exit conference was extended until May 13, 2002 and ATT was sent additional material clarifying which documents would be treated as temporarily confidential.

On May 8, 2002, Staff filed those specified portions of the working papers with the Division of Records and Hearing Services.

On May 31, 2002, ATT filed a "Request for Specified Confidential Classification" concerning portions of these documents.

Attached is a June 17, 2002, letter from ATT Senior Attorney Virginia Tate to Beth Keating which clarifies the ATT's intent to file a "claim for confidential classification" in accordance with Rule 22.006(5), FAC.

Based upon the claim, we recommend documents 04983-02 and 05762-02 be held as confidential and the declassification date for these documents be established as May 8, 2007, at which time document 05762-02 may be returned to ATT and document 04983-02 may be destroyed.
