

FLORIDA MULTI-MEDIA SERVICES, INC."

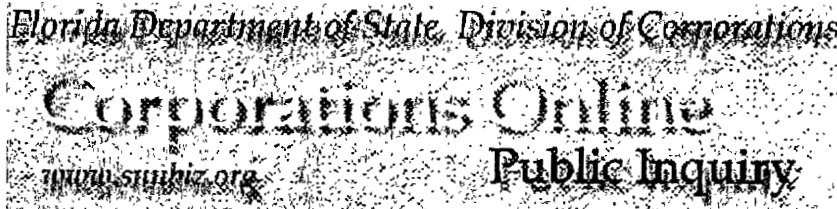
3. The foregoing amendment was approved by the written consent of the sole stockholder, which vote was sufficient for approval thereof on the 28 day of February, 2001.

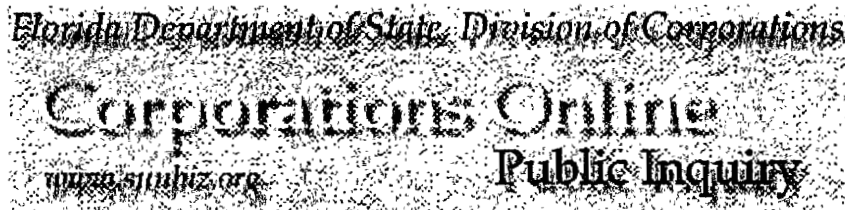

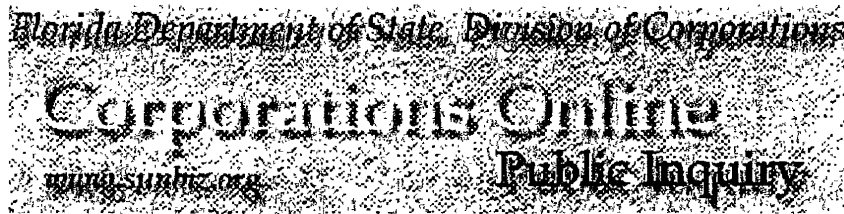
