1. On July 1, 2002, the Commission issued Order No. PSC-02-0878-FOF-TP in Docket No. 001305-TP.
2. The issuance of Commission Order No. PSC-02-0878-FOF-TP on July 1, 2002, denied Supra its procedural due process rights in this proceeding.
3. To preserve Supra’s procedural due process rights, Supra files its Motion to Stay Order No. PSC-02-0878-FOF-TP issued on July 1, 2002, pending judicial review in accordance with Rule 25-22.061(2), *Florida Administrative Code*.
