Dear Mr. LaChapelle:

The Regulatory Assessment Fee (RAF) is due by January 30<sup>th</sup> of each year for the preceding calendar year. For certificate holders, the RAF is owed even if a telecommunications company may not have started operations or had any revenues. 

#### 25-24,474 Cancellation of a Certificate.

- (1) The Commission may on its own motion cancel a company's certificate for any of the following reasons:

- (3) Cancellation of a certificate shall be ordered subject to the holder providing the information required by subsection (2).
