



Paula, attached is a copy of the request dated 1/12/02 from Global Crest Communications, Inc. for a name change. This was not docketed because RAFs had not been paid. Steinhart's office was contacted and told about the RAFs. Also attached are my e-mails for 2/7, 2/18, 2/27, 3/8, 3/15, and 4/2. All during this time I was calling Steinhart's office, asking for up-dates on the RAFs and was told they were working on it.

During the 4/2 call I informed Steinhart's office that I wanted to contact the company directly but the telephone number listed for them in MCD was not working. I was told the contact person at Global Crest had changed to Sheila Vick and was given a new telephone number of 305-891-5668. This info was sent to Nonnye. However, I was told to speak with Kelly Hall on the RAFs.

I did speak with Kelly and on May 10 I mailed her a RAF form. On or near May 23 I called Kelly again because we had not received the RAF. She said she did not get the form. I told her I would fax her the form and who to call if she had any problems on the P&I. On May 23 I faxed her the RAF form.

Since it appears that I am not getting any assistance from the attorney's office on collecting the RAF and since the company has not responded I don't know of anything else I can do in Certification.
