JOINT PETITION FOR ACKNOWLEDGMENT OF CORPORATE REORGANIZATION AND JOINT APPLICATION FOR THE APPROVAL OF A NAME CHANGE

Southlake Utilities, Inc. (hereinafter sometimes referred to as "Southlake"), a Florida corporation, and Southlake Water Works, L.L.C. (hereinafter sometimes referred to as "Water Works"), a Delaware limited liability company, (Southlake and Water Works are hereinafter sometimes collectively referred to as "Applicants"), hereby jointly petition the Florida Public Service Commission (hereinafter sometimes referred to as the "Commission") for acknowledgment of a corporate reorganization and hereby jointly make application to the Commission for the approval of a name change.

General Information

 The full name and address of Southlake are as follows: Southlake Utilities, Inc. 16554 Crossings Boulevard, Suite 2 Clermont, FL 34711

Southlake is a Florida corporation established on August 27, 1990. Southlake provides water and wastewater utility service in Lake County, Florida pursuant to Water Certificate No. 533-W and Wastewater Certificate No. 464-S through its water and wastewater utility systems (hereinafter referred to as the "Utility").

2. The full name and address of Water Works are as follows:

Southlake Water Works, L.L.C. 16554 Crossings Boulevard, Suite 2 Clermont, FL 34711

Water Works is a Delaware limited liability company organized on May 7, 2002. Water Works does not own any other water or wastewater utilities.

3. The full name, address, and telephone number of the individuals to contact concerning this petition are as follows:

4. In Order No. PSC-01-1671-FOF-WS, the Commission approved the transfer of majority organizational control of Southlake to Southlake Utilities Holding, L.L.C. (hereinafter sometimes referred to as "Holding"). The sole member of Holding was Cagan Crossing, Ltd. (hereinafter sometimes referred to as "Ltd").

5. On March 1, 2002, Holding closed the purchase whereby it acquired majority organizational control of Southlake pursuant to the above referenced Commission Order. Charts showing the ownership organization before and after the acquisition are attached as Exhibits 1 and 2, respectively.

6. Southlake and Water Works intend to transfer the facilities of Southlake and certificates of authorization granted to Southlake by the Commission from Southlake to Water Works.

Information Regarding Reorganization

7. Water and wastewater utility companies are generally required to notify the Commission of reorganizations even when the reorganization does not constitute a transfer. Order No. 24398, Order Acknowledging Corporate Reorganization and Name Change, <u>In</u>

re: Petition for Acknowledgment of Corporate Reorganization and Name Change on Certificates Nos. 502-W and 436-S in Nassau County from Sunray Utilities, Inc., to Sunray Utilities - Nassau, Inc., Docket No. 910166-WS, issued on April 22, 1991, 1991 FPSC Reporter 4:290. Accordingly, Southlake and Water Works are filing a Joint Petition for Acknowledgment of Corporate Reorganization (hereinafter sometimes referred to as the "Petition").

8. Subsequent to March 1, 2002, and prior to the date of this Petition, Southlake and its owners completed the initial phase (hereinafter sometimes referred to as "Phase One") of a two-phase plan of reorganization of the ownership structure of Southlake. There was no change in the majority organizational control of Southlake because the ultimate majority owner never changed during Phase One.

9. Southlake, Inc., originally owned sixty percent (60%) of Southlake. In step 1 of Phase One, the stock in both Southlake and Southlake, Inc., which had been acquired by Holding on March 1, 2002, was distributed by Holding to Ltd., which was the sole member of Holding. As a result of such initial distribution, one intermediate entity in the organizational structure (<u>i.e.</u>, Holding) was deleted. See attached Exhibit 3.

10. In step 2 of Phase One, the stock in Southlake and Southlake, Inc., recently acquired and then held by Ltd., was then distributed to its partners who participated in the Southlake investment. As a result of such distribution, a second

intermediate entity in the organizational structure (<u>i.e.</u>, Ltd.) was deleted. See attached Exhibit 4.

11. In step 3 of Phase One, Southlake, Inc., was merged vertically into Southlake with Southlake being the surviving corporation. As a result of such merger, a third intermediate entity in the organizational structure (<u>i.e.</u>, Southlake, Inc.) was deleted, even further simplifying the ownership and completing the portion of the reorganization for 2002. See attached Exhibits 5 and 6.

12. In phase two of the reorganization (hereinafter sometimes referred to as "Phase Two"), which is scheduled to be completed early in 2003, a limited liability company (<u>i.e.</u>, Water Works) was formed as a one hundred percent (100%) wholly-owned subsidiary of Southlake (Step 4); and (ii) assets of Southlake, including its rights under the Certificates of Authorization, will be transferred to Water Works (Step 5). See Exhibits 7 and 8.

Analysis of Reorganization

13. <u>Phase One</u>. The reorganization accompanied by Phase One did not affect the ultimate ownership or control of the Utility. Such ownership and control remained with Richard Driehaus and Jeffrey Cagan, who are, far and away, the greater majority owners. All assets remained with Southlake. The principal officers, the office, and the operations personnel did not change because of Phase One. All that occurred was that three former intermediate shareholders of Southlake (which were <u>not</u> individuals) were deleted from Southlake's organizational structure and Southlake's

organizational structure, as a result, was greatly simplified. The Commission's well-settled practice is that such reorganization understandably enough does not reach the level of a transfer under Section 367.071, Florida Statutes. The reorganization scheduled for 14. Phase Two. completion in the year 2003, through the utilization of the wholly owned subsidiary (i.e., Water Works), including the transfer of assets of Southlake, including facilities and certificates, from Southlake to that subsidiary, likewise does not require Commission approval as a transfer. The reorganization through the use of the subsidiary will not affect the ultimate ownership or control of the Utility which will remain with Richard Driehaus and Jeffrey Cagan, its greater majority owners. The principal officers, the office, and the operations personnel will not change because of the use of the subsidiary. All that will occur is that a subsidiary will be inserted into the organizational structure of Southlake and operate the Utility in its name. The Commission's practice is that such a reorganization does not reach the level of transfer under Section 367.071, Florida Statutes. See Order No. PSC-95-0578-FOF-WU, Order Acknowledging Corporate Reorganization, In Re: Petition for acknowledgment of corporate reorganization by The Peoples Water Service Company in Escambia County, Docket No. 950319, issued on May 9, 1995, 1995 FPSC Reporter 5:234; Order No. 24240, Order Acknowledging Restructuring and Changing Name on Certificates, In re: Request for Acknowledgment of Restructuring and Name Change on Certificates Nos. 353-W and 309-S in Lee County from FFEC-SIX, INC.

to FFEC-SIX, LTD., Docket No. 910180-WS, issued on March 14, 1991, 1991 FPSC Reporter 3:397; Order No. PSC-01-1499-FOF-WS, Order Acknowledging Corporate Reorganization, Approving Change in Name of In Re: Application for Utility, and Closing Docket, the acknowledgment of corporate reorganization and name change on Certificate Nos. 417-S and 481-W in Broward County from MHC-DeAnza Financing Limited Partnership d/b/a Colonies Water Company, to CM Utility Systems, L.L.C. d/b/a Colonies Water Company, Docket No. 010670-WS, issued on July 18, 2001, 2001 FPSC Reporter 7:189. In all of these cases, one or more wholly owned subsidiaries were inserted into the organizational structure of a utility below the company previously holding the Certificates of Authorization. In all of these cases, the Commission consistently did not require an application for approval of transfer. The Commission stated in two of these cases that the reorganization did not rise to the level of a transfer under Section 367.071, Florida Statutes.

Additional Information Needed for Application for a Name Change

15. As part of the reorganization, the Utility will be operated by Water Works in the name of Water Works, and, accordingly, a name change is required.

16. Water Works was organized on May 7, 2002, and a copy of its Certificate of Formation is attached as Schedule A. The effective date for the Utility to use Water Works as its name will not occur until after Phase II is completed in 2003. As set forth above, the ownership and control of the Utility and its assets will

remain with Richard Driehaus and Jeffrey Cagan under the proposed name.

17. A proposed notice to be sent to the customers of the Utility is attached as Schedule B.

18. An original and two copies of the tariff reflecting the name change have been submitted with this application.

19. Southlake's original certificates were submitted with the application. A copy of the certificates are attached as Schedule C.

Request for Relief

20. Applicants, believing that neither Phase One nor Phase Two constitute an effective change of either ownership or control of Southlake so as to require Commission approval under Section 367.071, Florida Statutes, hereby request that the Commission acknowledge the corporate reorganization of the ownership of Southlake as set forth in paragraphs 8, 9, 10, 11, and 12 of the Application (<u>i.e.</u>, Phase One and Phase Two) and that no further action on the part of Southlake or Water Works is required before the Commission regarding such reorganization.

21. Southlake and Water Works further request that the Commission approve the proposed name change. Applicants have provided the information required by Section 367.01214, Florida Statutes (2002), and Rule 20-30.039, Florida Administrative Code, in this Application and its Attachments, Exhibits and Schedules.

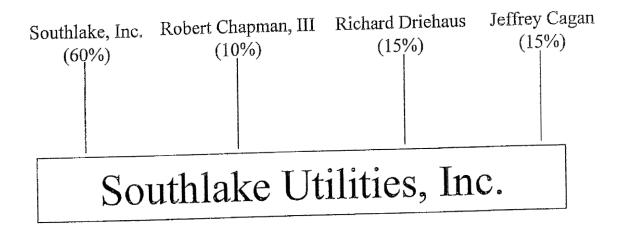

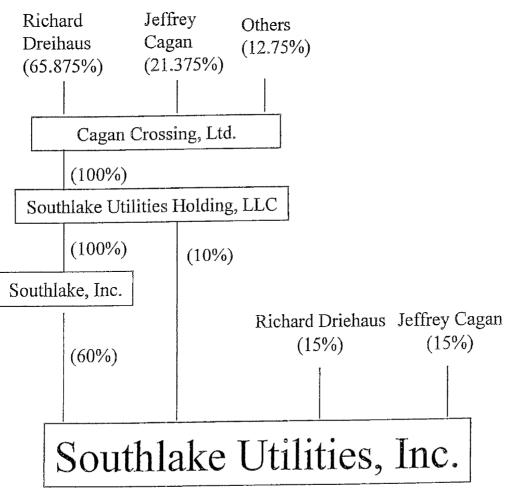

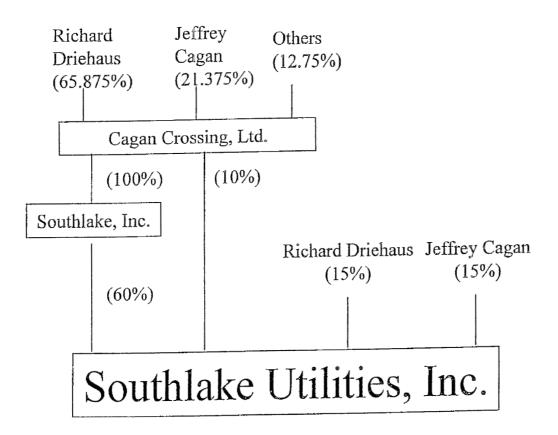
Organizational Chart Prior to Acquisition of Majority Organizational Control In Accordance with Order No. PSC-01-1671-FOF-WS Exhibit 1



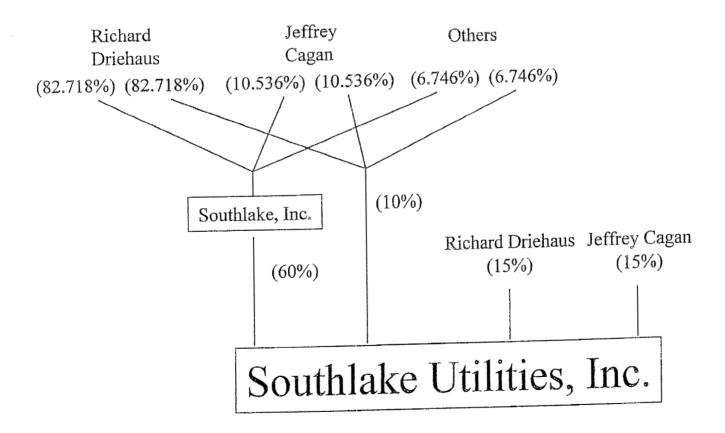
Organizational Chart Following Acquisition of Majority Organizational Control In Accordance with Order No. PSC-01-1671-FOF-WS Exhibit 2



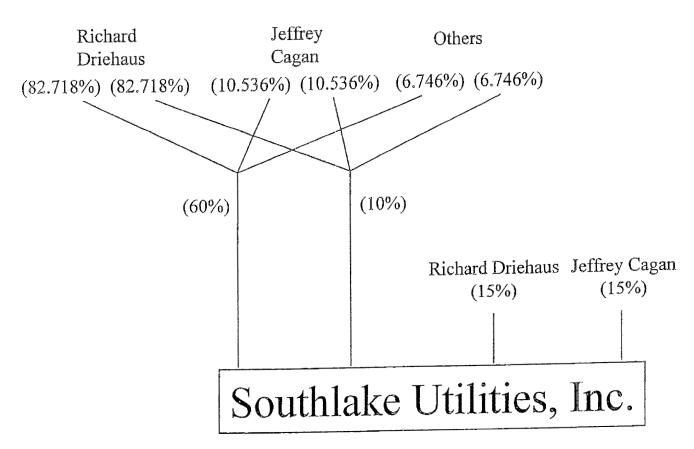

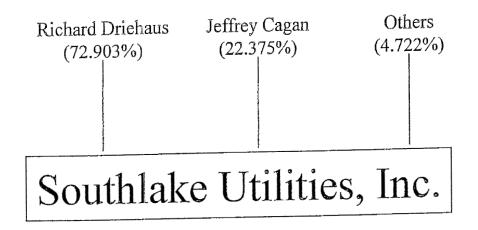

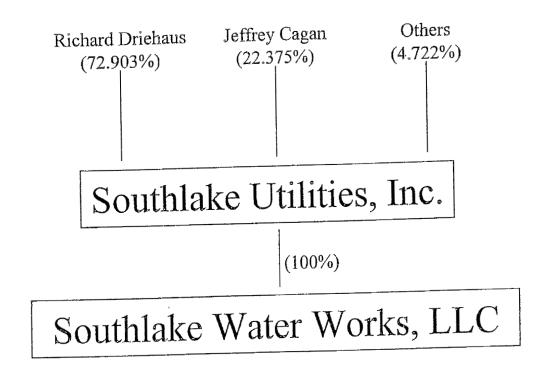

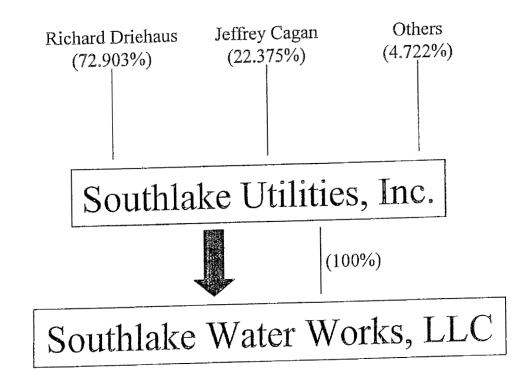
Reorganization – Phase One – Step Three B Summary of Ownership Interests after Step Three A Exhibit 6
