1. On July 1, 2002, BellSouth Telecommunications, Inc. filed a Petition for Expedited Review of Growth Code Denials by the North American Numbering Administration for the Miami Exchange (Palmetto), along with Attachments 1, 2 and 3. Attachments 1 and 3 contain information that is considered confidential and proprietary to BellSouth. BellSouth also filed a Notice of Intent to Request Specified Confidential Classification for Attachments 1 and 3 on that same day.

3. BellSouth has treated and intends to continue to treat the information for which confidential classification is sought as private, and this information has not been generally disclosed.


4. Appended hereto as Attachment B are two copies of the requested documents with the confidential information deleted.
