RE: Docket No. 020514-TC - Cancellation by Florida Public Service Commission of PATS Cert. No. 7752 issued to Carlton Palms Condominium Association, Inc. for violation of Rules 25-24.0161, F.A.C., Regulatory Assessment Fees; Telecommunications Companies, and 25-24.520, F.A.C., Reporting Requirements.

ISSUE 1: Should the Commission impose a \$500 penalty or cancel Carlton Palms Condominium Association, Inc.'s Pay Telephone Service (PATS) Certificate No. 7752 for apparent violation of Rule 25-4.0161, Florida Administrative Code, Regulatory Assessment Fees; Telecommunications Companies?

RECOMMENDATION: Yes. The Commission should impose a \$500 penalty or cancel the company's certificate if the penalty and the regulatory assessment fees, including statutory penalty and interest charges, are not received by the Commission within fourteen (14) calendar days after the issuance of the Consummating Order. The penalty should be paid to the Florida Public Service Commission and forwarded to the Office of the Comptroller for deposit in the State General Revenue Fund pursuant to Section 364.285(1), Florida Statutes. If the Commission's Order is not protested and the penalty and regulatory assessment fees, including statutory penalty and interest charges, are not received, the company's Certificate No. 7752 should be cancelled administratively and the

collection of the past due fees should be referred to the Office of the Comptroller for further collection efforts. If the company's certificate is cancelled in accordance with the Commission's Order from this recommendation, Carlton Palms Condominium Association, Inc. should be required to immediately cease and desist providing pay telephone service in Florida.

## DEFERRED

ISSUE 2: Should the Commission impose a \$500 penalty or cancel Carlton Palms Condominium Association, Inc.'s PATS Certificate No. 7752 for apparent violation of Rule 25-24.520, Florida Administrative Code, Reporting Requirements?

RECOMMENDATION: Yes. The Commission should impose a \$500 penalty or cancel Carlton Palms Condominium Association, Inc.'s certificate if the information required by Rule 25-24.520, Florida Administrative Code, Reporting Requirements, and penalty are not received by the Commission within fourteen (14) calendar days after the issuance of the Consummating Order. The penalty should be paid to the Florida Public Service Commission and forwarded to the Office of the Comptroller for deposit in the State General Revenue Fund pursuant to Section 364.285(1), Florida Statutes. If the Commission's Order is not protested and the penalty and required information are not received, Carlton Palms Condominium Association, Inc.'s PATS Certificate No. 7752 should be cancelled administratively. If the company's certificate is cancelled in accordance with the Commission's Order from this recommendation, Carlton Palms Condominium Association, Inc. should be required to immediately cease and desist providing pay telephone service in Florida.
