
Dear Mr. Williams:

On July 18, 2002, A.R.C. Networks, Inc. d/b/a InfoHighway ("InfoHighway") and North American Communications Control, Inc. ("NACC") made the above-referenced filing, which was assigned Docket No. 020757-TI. A July 19, 2002 letter from the Commission describes the filing as including a request for cancellation of NACC's certificate, Certificate No. 4463. Please be advised that NACC does not intend to cancel its certificate at this time.

The parties' July 18, 2002 filing is intended only to notify the Commission of the transfer of the customer base from NACC to InfoHighway and to obtain a waiver of Commission Rule 25-4.118, as that rule would apply to InfoHighway. The July 18, 2002 filing requests no action with respect to NACC's certificate.
