Dear Mr. Hasan:

The Commission has received your letter dated July 12, 2002 requesting cancellation of your pay telephone certificate. The effective date of a voluntary cancellation is the date the Commission received the company's request for cancellation. In this case, the Commission received your request July 19, 2002, therefore, the company will only owe the 2002 Regulatory Assessment Fee (RAF).

Rule 25-24.514, Florida Administrative Code, provides that a telecommunications company must either pay the current year's RAF or provide a date certain it will be paid. In case you decide to go ahead and pay the 2002 RAF, the form is enclosed. Otherwise, you need to write a letter advising when the 2002 RAF will be paid (due by January 30, 2003).
