

ITC^DeltaCom, Inc. ("ITC^DeltaCom") hereby files this Notice of Intent to Request Specified Confidential Classification pursuant to Rule 25.22.006, Florida Administrative Code.

In support, ITC^DeltaCom states as follows:

1. On July 29, 2002, ITC^Delta Com, Inc. filed Rebuttal Testimony of Steve Brownworth. Mr. Brownworth's Rebuttal Testimony contains confidential proprietary information belonging to BellSouth Telecommunications, Inc. ("BellSouth"). The confidential information was redacted from the public version of Mr. Brownworth's testimony, and a confidential version was filed under separate cover.
2. The confidential information was derived from BellSouth's Confidential Exhibit No. JAR-1, filed in connection with the direct testimony of John A. Ruscilli. BellSouth filed a Request for Confidential Classification of the entire exhibit on July 22, 2002. ITC^DeltaCom therefore does not believe it is necessary to file a Notice or Request to maintain the confidential status of this information. In an abundance of caution, however, ITC^DeltaCom, Inc. is filing this Notice of Intent to Request Specified Confidential Classification pursuant to Rule 25-22.006(3)(a), Florida Administrative Code. 


