
**Re: Adelpia Business Solutions Investment East, L.L.C. - Tariff Filing No. T-01-1326**

In response to your letter regarding Adelpia Business Solutions Investment East, L.L.C.'s ("ABS East") intrastate interexchange tariff, we advised you on April 25, 2002 that, in light of recent business and market developments, ABS East was reconsidering the viability of its operational plans in Florida. After evaluating a number of factors, ABS East recently concluded that it will not commence telecommunications operations in the near future in Florida. Accordingly, ABS East respectfully requests that the Commission cancel without prejudice ABS East's Certificate Nos. 8045 (alternative local exchange) and 8046 (interexchange), awarded in Docket No. 011638-TX on March 26, 2002, and Docket No. 011598-TI on March 22, 2002, respectively.
