PLEASE TAKE NOTICE THAT on August 16, 2002, the Court entered an order (the "Bar Date Order") establishing <u>September 30, 2002, at 5:00 p.m.</u>, Prevailing Eastern Time (the "Bar Date") as the last date and time for the filing of proofs of claim against Global Crossing Ltd. and its debtor subsidiaries (collectively, the "Debtors"). The Bar Date and the procedures set forth below for the filing of proofs of claim apply to all claims against the Debtors that arose prior to January 28, 2002 (the "Debtors' Commencement Date"), April 24, 2002 for claims against GT U.K. Ltd. (the "GTUK Commencement Date") and August 4, 2002 for claims against SAC Peru S.R.L. (the "SAC Peru Commencement Date," and together with the Debtors' Commencement Date and the GTUK Commencement Date, the "Commencement Dates").

DOCUMENT NUMBER-DATE

Under section 101(5) of the Bankruptcy Code and as used herein, the word "claim" means: (a) right to payment, whether or not such right is reduced to judgment, liquidated, unliquidated, fixed, contingent, matured, unmatured, disputed, undisputed, legal, equitable, secured, or unsecured; or (b) right to an equitable remedy for breach of performance if such breach gives rise to a right to payment, whether or not such right to an equitable remedy is reduced to judgment, fixed, contingent, matured, unmatured, disputed, undisputed, secured or unsecured.

2. WHO SHOULD <u>NOT</u> FILE A PROOF OF CLAIM

You should not file a proof of claim if:

- A. You have <u>already</u> properly filed, with the Clerk of the United States Bankruptcy Court for the Southern District of New York, a proof of claim against the Debtors, utilizing a claim form which substantially conforms to the Proof of Claim or Official Form No. 10;
- B. Your claim is listed on the Debtors' Statements of Financial Affairs, Schedules of Assets and Liabilities and Schedules of Executory Contracts (collectively, the "Schedules"), is <u>not</u> described as "disputed," "contingent," or "unliquidated," <u>and</u> you do not dispute the amount or nature of your claim as set forth in the Schedules;
- C. You have a claim for an administrative expense, as such term is used in sections 503(b) and 507(a) of the Bankruptcy Code;
- D. Your claim has already been paid by the Debtors;
- E. You are a person or entity that holds a claim arising out of or based solely upon an equity interest in the Debtors;
- F. You are a person or entity whose claim is limited exclusively to the repayment of principal, interest, and/or other applicable fees and charges (a "Debt Claim") on or under any bond or note issued by the Debtors (the "Debt Instruments"); **provided**, **however**, that (i) the foregoing exclusion in this subparagraph shall not apply to the Indenture Trustee under the applicable Debt Instruments (the "Indenture Trustee"), (ii) the Indenture Trustee shall be required to file one proof of claim, on or before the Bar Date, on account of all of the Debt Claims on or under each of the Debt Instruments and (iii) any holder of a Debt Claim wishing to assert a claim, other than a Debt Claim, arising out of or relating to the Debt Instrument shall be required to file a proof of claim on or before the Bar Date, unless another exception in this paragraph applies;

- G. You hold a claim that has been allowed by an order of this Court entered on or before the Bar Date;
- H. You hold a claim solely against any of the Debtors' non-debtor affiliates; and
- I. You are a Debtor and you have a claim against another Debtor.

YOU SHOULD NOT FILE A PROOF OF CLAIM IF YOU DO NOT HAVE A CLAIM AGAINST THE DEBTORS, OR IF THE CLAIM YOU HELD ON THE COMMENCEMENT DATES HAS BEEN SATISFIED.

3. EXECUTORY CONTRACTS AND UNEXPIRED LEASES

Any person or entity that holds a claim that arises from the rejection of an executory contract or unexpired lease as to which the order authorizing such rejection is dated at least ten (10) days prior to the Bar Date, must file a proof of claim based on such rejection of an before the Bar Date. Any person or entity that holds a claim that arises from the rejection of an executory contract or unexpired lease as to which the order authorizing such rejection is dated less than ten (10) days prior to the Bar Date or thereafter, must file a proof of claim on or before such date as the Court may fix in the applicable rejection order.

INSTRUCTIONS FOR PROOF OF CLAIM FORM

The instructions and definitions below are general explanations of the law. In particular types of cases or circumstances, such as bankruptcy cases that are not filed voluntarily by a debtor, there may be exceptions to these general rules.

- DEFINITIONS -

Debtor

The person, corporation, or other entity that has filed a bankruptcy case is called the debtor.

Creditor

A creditor is any person, corporation, or other entity to whom the debtor owed a debt on the date that the bankruptcy case was filed.

Proof of Claim

A form telling the bankruptcy court how much the debtor owed a creditor at the time the bankruptcy case was filed (the amount of the creditor's claim). This form must be filed with the clerk of the bankruptcy court where the bankruptcy case was filed.

Secured Claim

A claim is a secured claim to the extent that the creditor has a lien on property of the debtor (collateral) that gives the creditor the right to be paid from that property before creditors who do not have liens on the property.

Examples of liens are a mortgage on real estate and a security interest in a car, truck, boat, television set, or other item of property. A lien may have been obtained through a court proceeding before the bankruptcy case began; in some states a court judgment is a lien. In addition, to the extent a creditor also owes money to the debtor (has a right of setoff), the creditor's claim may be a secured claim. (See also *Unsecured Claim*.)

Unsecured Claim

If a claim is not a secured claim it is an unsecured claim. A claim may be partly secured and partly unsecured if the property on which a creditor has a lien is not worth enough to pay the creditor in full.

Unsecured Priority Claim

Certain types of unsecured claims are given priority, so they are to paid in bankruptcy cases before most other unsecured claims (if there is sufficient money or property available to pay these claims). The most common types of priority claims are listed on the proof of claim form. Unsecured claims that are not specifically given priority status by the bankruptcy laws are classified as Unsecured Nonpriority Claims.

Items to be completed in Proof of Claim form (if not already filled in)

Court, Name of Debtor, and Case Number:

A complete list of Debtors with corresponding case numbers is listed on the other side of this page. You **MUST** fill in the specific Debtor against which your claim is being asserted. If you are asserting claims against more than one Debtor, you **MUST** file a separate proof of claim for each Debtor. If you do not include the specific Debtor against which your claim is being asserted, your claim will be disallowed.

Information about Creditor:

Complete the section giving the name, address and telephone number of the creditor to whom the debtor owes money or property, and the debtor's account number, if any. If anyone else has already filed a proof of claim relating to this debt, if you never received notices from the bankruptcy court about this case, if your address differs from that to which the court sent notice, or if this proof of claim replaces or changes a proof of claim that was already filed, check the appropriate box on the form.

1. Basis for Claim:

Check the type of debt for which the proof of claim is being filed. If the type of debt is not listed, check "Other" and briefly describe the type of debt. If you were an employee of the debtor, fill in your social security number and the dates of work for which you were not paid.

2. Date Debt Incurred:

Fill in the date when the debt first was owed by the debtor.

3. Court Judgments:

If you have a court judgment for this debt, state the date the court entered the judgment.

4. Total Amount of Claim at Time Case Filed:

Fill in the amount of the entire claim. If interest or other charges in addition to the principal amount of the claim are included, check the appropriate place on the form and attach an itemization of the interest and charges.

5. Secured Claim

Check the appropriate place if the claim is a secured claim. You must state the type and value of property that is collateral for the claim, attach copies of the documentation of your lien, and state the amount past due on the claim as of the date the bankruptcy case was filed. A claim may be partly secured and partly unsecured. (See DEFINITIONS, above).

6. Unsecured Priority Claim

Check the appropriate place if you have an unsecured priority claim, and state the amount entitled to priority. (See DEFINITIONS, above). A claim may be partly priority and partly nonpriority if, for example, the claim is for more than the amount given priority by the law. Check the appropriate place to specify the type of priority claim.

7. Credits:

By signing this proof of claim, you are stating under oath that in calculating the amount of your claim you have given the debtor credit for all payments received from the debtor.

8. Supporting Documents:

You must attach to this proof of claim form copies of documents that show the debtor owes the debt claimed or, if the documents are too lengthy, a summary of those documents. If documents are not available, you must attach an explanation of why they are not available.
