Re: Docket No. 020344-SU, Application for increase in Wastewater rates in Monroe County by Key Haven Utility Corporation.

Dear Mr. Friedman:

We have reviewed the minimum filing requirements (MFRs) submitted on August 13, 2002, on behalf of the above-mentioned utility. Based on our analysis, we believe the MFRs to be deficient. The specific deficiencies are listed below:

A. MAPS

Pursuant to Rule 25-30.440(1)(a), Florida Administrative Code (FAC), the applicant is required to submit a detailed map showing the location and size of the applicant's distribution and collection lines as well as its plant sites. The map that was submitted by the utility does not show the location and size of the collection lines, as well as the location of the wastewater treatment plant. Therefore, the map that was submitted by the utility is deficient.

B. RELATED PARTY COST ALLOCATIONS

Rule 25-30.436(4)(h), FAC , states in part, any system that has costs allocated or charged to it from a parent, affiliate, or related party, in addition to those costs reported on Schedule B-12 of Commission Form PSC/ECR 20 for a Class B utility, shall file three copies of the additional information described in Rule 25-30.436(4)(h), FAC. The utility must submit this additional information in order to provide sufficient detail of its related party costs.

C. SCHEDULE ERROR

Schedule B-2, line three in the MFRs, lists "Depreciation, net of CIAC am"(ortization), in the amount of \$63,872. Schedule F-3(a), column (e), of the 2001 Annual Report, lists Depreciation Expense at \$51,167 and CIAC Amortization at \$12,705 respectively. Net Depreciation Expense should be \$38,462 as stated in schedule F-3(a), column (e), of the 2001 Annual Report.


