Knight Water Utility, Inc., 7092 Placida Road, Cape Haze, Florida 33946 pursuant to Sections 367.031 and 367.045, Florida Statutes, hereby notices its intent to apply to the Florida Public Service Commission for a certificate to provide water service to the following described property in Charlotte County, Florida:

That portion of Sections 19, 20 and 29 in Township 41 south, Range 20 East bounded on the west by the Gulf of Mexico, on the East by the Intercoastal Waterway, on the North by Stump Pass and on the South approximately by the South line of the North One-Half of the aforementioned Section 29, consisting of a portion of Thornton Key and Knight Island and further on the South by the Northerly limit of the Bocilla Utilities Inc. Franchise Service Area.
