**NOTICE OF INTENT TO REQUEST
CONFIDENTIAL CLASSIFICATION**

Florida Power Corporation ("Florida Power" or the "Company"), pursuant to Section 366.093, Fla. Stat., and Rule 25-22.006, F.A.C., files this notice of intent to request confidential classification of confidential appendix J to the Need Study filed as Exhibit __ JBC-1 to the testimony on John B. Crisp in support of Florida Power's Petition for a Determination of Need for its Hines 3 power plant. Confidential appendix J to Florida Power's Need Study contains a detailed description of the proposals provided by bidders in response to the RFP issued by Florida Power on November 26, 2001 pursuant to Rule 25-22.082, F.A.C. Accordingly, Florida Power hereby submits the following.
