Dear Customer: Effective September 2002, LDMI will be implementing the following billing policies which may impact some of our customers. We trust you will understand the need to enforce these policies. Please direct any concerns to Customer Care at 800-374-5364.

Late Fees: Balances not paid by the invoice due date will be subject to a 1% charge on the unpaid balance depending on state regulations.

NSF Checks: To cover our processing costs and fees charged by our bank, a fee of \$25 will be assessed for any check returned by the bank as "Non-Sufficient Funds".

Directory Assistance Charges: In keeping with the industry, the charge for a Directory Assistance call will increase to a maximum \$.95 per use depending on state regulation. The local Directory Assistance call allotment in Michigan has been discontinued.

Long Distance Monthly Minimum Charge: Due to the high cost of billing and processing, long distance customers whose usage is less than \$4.00 on any invoice will be assessed a \$4.00 fee on that invoice.

Account Change Fee: Customers who request a change of rate plans will be asked to pay a \$5.00 account change fee to cover our processing costs.
