#### STATUS REPORT

Petitioner, the City of Bartow, Florida, by and through its undersigned attorneys and in compliance with the order of the Florida Public Service Commission dated July 12, 2002, submits the following status report:

- 1. On July 12, 2002, the Florida Public Service Commission ("Commission") granted the City of Bartow's ("Bartow") motion for continuance.
- 2. On page 5 of that order, the Commission requested that Bartow file a status report on configuration of the Old Florida Plantation and indicated that Bartow is not precluded from filing both a status report and a revised petition by September 16, 2002.
- 3. 
