ALLTEL’S UNOPPOSED MOTION
FOR ONE WEEK EXTENSION OF TIME
TO FILE DIRECT AND REBUTTAL TESTIMONY

ALLTEL Florida, Inc. (“ALLTEL”), by and through its undersigned counsel, and pursuant to Rule 28-106.204, Florida Administrative Code, hereby request that the Florida Public Service Commission (“FPSC” or “Commission”) extend the filing dates in this case for direct and rebuttal testimony by seven (7) days, and states:

1. Issue 3 in this docket involves how the “local calling area” should be defined for purposes of reciprocal compensation, in general, and whether that definition should be suspended or modified pursuant to Section 251(f)(2) of the 1996 Telecommunications Act.

2. On September 10, 2002, the Florida Public Service Commission issued Order No. PSC-02-1248-FOF-TP in Docket No. 000075-TP (Phases II and IIA) (“Generic Local Calling Area Order”). That order addresses the generic definition of local calling area for reciprocal compensation purposes.

3. Under the current case schedule, direct and rebuttal testimony is due for filing on September 20 and October 14, 2002, respectively. An additional seven days

would allow both parties sufficient time to analyze the Generic Reciprocal Compensation Order and to factor that order into their testimony in this case. Accordingly, ALLTEL requests that the dates for filing direct and rebuttal testimony in this docket be extended to September 27 and October 21, 2002, respectively, with no changes to the remainder of the present case schedule.




