1. On August 29, 2002, BellSouth Telecommunications, Inc. filed a Petition for Expedited Review of NXX Code Denial for the Orlando Exchange (Magnolia), along with Attachments 1, 2 and 3. 3. BellSouth has treated and intends to continue to treat the information for which confidential classification is sought as private, and this information has not been generally disclosed.


4. Appended hereto as Attachment B are two copies of the requested documents with the confidential information deleted.


