Florida Power & Light Company ("FPL") hereby files this Notice of Intent to Use Confidential Information at Hearing ("Notice") pursuant to Order No. PSC-02-0992-PCO-EI. FPL has determined that it intends to use at hearing confidential Appendices C-1 through C-7 to FPL's Need Study filed in these proceedings. These documents have been listed as Document No. 07402-02 in these proceedings. On August 22, 2002, the Commission granted confidential classification of these documents by Order No. PSC-02-1150-CFO-EI. Because the confidential nature of the information contained in these documents has been approved by the Commission and a procedure is already in place to preserve the confidentiality of these documents as required by statute, this Notice does not include an additional procedure for the preservation of confidentiality. FPL retains the right to file additional notices of intent to use confidential information at hearing pursuant to Order No. PSC-02-0992-PCO-EI, if FPL later identifies additional confidential information it intends to use at hearing.


