

Please accept this fax as our notice of objection to the above proposal.

We wish to point out that ten years ago the residents of Knight, Don Pedro and Palm Island voted NOT to have commercial enterprise of any kind on these islands, with the exception of the restaurant and store in Palm Island Resort, and the Pelican inn on Knight Island, which were already in operation. It is also my understanding that the State is trying to discourage development of barrier islands. This particular project would undoubtedly cause a rapid increase in the development and density.

We strongly object to the above application and would request the Commission reject the proposal.
