

On July 22, 2002, Southlake Utilities, Inc. ("Southlake"), and Southlake Waterworks, L.L.C. ("Water Works"), filed an Application with the Florida Public Service Commission ("Commission") for acknowledgment of corporate reorganization and an application for the approval of a name change. Southlake undertook a two phase reorganization of its organizational structure which added Water Works as a wholly-owned subsidiary of Southlake and eliminated several intermediate companies from the organizational structure. As a part of this implementation of the corporate reorganization, the customers will now be served directly by Water Works. Water Works has been authorized to use the name "Southlake Utilities."
