Dear Ms. Bayo:

Pursuant to Commission Rule 25-24.474 (cancellation of a certificate), by this letter Dynegy Communications Clearinghouse, Inc. (DCC) requests cancellation of its Alternative Local Exchange Telecommunications Certificate No. 7838.

DCC never engaged in the provision of telecommunication services to the public for hire, but rather operated in limited circumstances as an interstate carriers' carrier. DCC obtained its ALEC certificate in good faith as a predicate to engaging in the regulated provision of intrastate telecommunication services for hire. DCC has made the business decision not to enter this business, and thus it is no longer appropriate to maintain the license. DCC never had any customers.

As contemplated by Rule 25-4.0161, Florida Administrative Code, attached is DCC's completed Regulatory Assessment Fee form and the required payment of \$53.00.
