
Crystal Clear Management was recently notified that Docket No 020803-TC was opened for Donatella Communications LLC. For non-payment of the 2001 Regulatory Assessment Fee and for not providing updated address and contact person.

First, attached is our check, along with any interest charges and the Regulatory Assessment Fee. Crystal Clear Management Inc. has taken the corrective steps to prevent this oversight again. We have taken over the responsibility of paying these fees for Donatella Communications LLC. We are now aware that these fees are due by January 30 of every year.

Second of all a staff member was to notify the Commission of our new address and status with Donatella Communication LLC. For some reason this was not completed. This was a complete oversight. We believed all these fees were being paid at the Palm Beach Office and they thought we took care of them. We have corrected the problem and taken over entire operation. We also realize that we are to send correct address changes within 10 days and you may be assured that this problem will not happen again. We also understand that if the commission accepts the \$200.00 it must be paid within 14 calendar days from the date of the order accepting the settlement.
