The Florida Municipal Power Agency (FMPA), by and through undersigned counsel, hereby files this Supplement to Motion for Extension of Time and states as follows:

1. One October 9, 2002, FMPA filed its Motion for Extension of Time, and stated that no party other than FIPUG (FIPUG supports the Motion) had responded to FMPA regarding its position on the Motion. That was an accurate statement at the time of filing the Motion.

2. Since then, several parties have contacted FMPA regarding their position on the Motion. FMPA is authorized to represent the positions of those parties as follows:

- a. Mirant Americas Development, Inc. and Calpine Corporation support the Motion.


