
Dear Mr. Sundstrom:

I have had an opportunity to discuss your September 25, 2002, correspondence with my client and respond as follows.

By now I am sure you have done a title search of the property and I am fairly confident that you know that my client still owns the collection system, but if there is any doubt please check Parcel Id 25-47-25-11-0000A.0010, which is the strap number for the lift station currently being maintained by my client. With respect to paragraph two of your letter, the waste water collection system was not sold at the Sheriff's sale. With respect to your allegations that you see no reason to meet with my client fact to face, I can respect that, but allow me to point out to you that although my client has currently attempted to terminate the Sewer Capacity Presale Agreement which your client is ignoring, if in fact my client no longer owns the collection system, then as a matter of law I believe the Sewer Capacity Presale Agreement is void. I could not find anything that would obligate a party's successor to this Presale Agreement. Once again my client is advising you that he has terminated the Sewer Capacity Presale Agreement and is demanding that all proceeds from any collection within this system be turned over to him immediately.

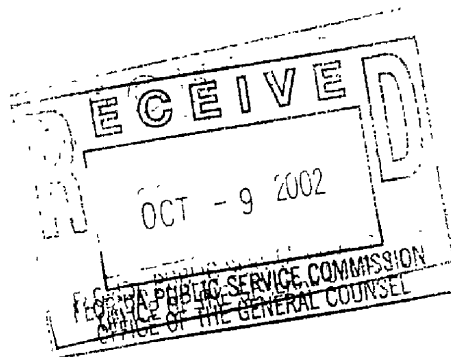


Dear Ms. Gervasi:

Please consider this our response to your September 27, 2002, correspondence. With respect to the question of ownership of the collection system, I offer the following proof.

Please find enclosed (Exhibit "A") copies of the original development orders from the Florida Department of Environmental Regulation indicating that a permit was, in fact, issued to J. F. Holzberg to construct and operate the initial waste water treatment plant including gravity filters and drain fields. This was apparently conducted under General Permit No. 17-555.540 and I assume you have access to the supporting documents referenced in these documents. Exhibit "B" is copies of the tax statements for the lift stations indicating that Fritz Holzberg has been paying the property taxes on same. Exhibit "C" is copies of Quit Claim Deeds from Mr. Holzberg individually to Gistro, Inc., for the lift stations and the collection system itself. Exhibit "D" is a copy of the Sewer Capacity Presale Agreement between Forest Mere Joint Venture and Bonita Springs Water Systems, Inc., which has been terminated by Gistro, Inc., as a successor in interest of Forest Mere Joint Venture. It is interesting to note that Mr. William E. Sundstrom wants to argue that my client no longer owns the system. If that is true then even though he is contesting the fact that my client can not cancel the presale agreement, if my client no longer owns this system, then the presale agreement can no longer be enforced by B.S.U. Outside of a complete title search, which I assume Mr. Sundstrom completed, I can not offer any additional proof. With respect to Mr. Sundstrom's representation that this property was somehow sold at a Sheriff's sale, I can advise you that sale was defective and transferred nothing.

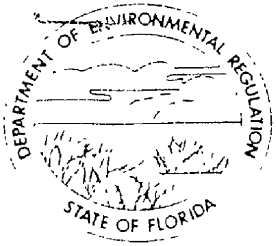

2. Provide an engineering report with reasonable assurance that the design will meet the requirements of F.A.C. Rules 17-6.035(1) thru (8), 17-6.036(1) thru (4); 17-6.037(1) thru (2) and 17-6.050 thru .575.
3. Provide reasonable assurance that the disinfection (chlorine) facilities are designed in accordance with F.A.C. Rules 17-6.040(4)(c), 17-6.070(1)(a) and 17-6.070(1)(c) thru (5).
4. Provide buffer in accordance with F.A.C. Rule 17-6.0571.



6. Indicate an easy access sampling point for the influent and effluent on the drawings in accordance with F.A.C. Rules 17-6.070(3), 170-6.070(4) and 17-6.070(5).
7. Provide baffles (details) in the chlorine contact chamber to ensure no short circuiting for disinfection.
8. Provide a copy of the O & M manual for this project or the draft manual as required in accordance with F.A.C. Rule 17-6.150(1) thru 17-6.150(2)(a)3.
9. Complete subpart E: Absorption Field System; item (9) page 18 of 31 and include mounding calculations for the absorption field system in accordance with F.A.C. Rule 17-610.573.
10. Provide drawing showing the existing and proposed plants modification. Also, check attachment I submitted with application. The clarifier dimension has an error on the size and the chlorine contact chamber dimension was omitted submit a revised page.
11. Provide assurance that the hydraulic loading to the treatment plants will not exceed average daily flow (ADF) of 24 gpm at 2 to 4 times the ADF design flow using the splitter box system in accordance with F.A.C. Rule 17-6.070(1)(c)2.

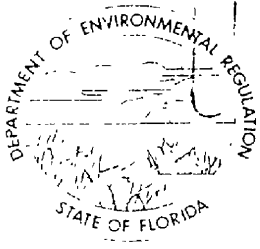

17-555.540 General Permit for the Construction of an Extension to a Public Water Supply Distribution System.

(1) A general permit is hereby granted for the construction of an extension to a public drinking water system that has been designed in accordance with the standards and criteria set forth in this Chapter provided that:

(a) Notice of the Department under Rule 17-4.530(1) F.A.C., is submitted on DER Form 17-555.910(1); and

(b) The treatment facility to which the system will be connected has the capacity to provide the potable water supply required by this system and is in compliance with the standards and criteria set forth in Chapters 17-550, 17-560, F.A.C., and this Chapter for the drinking water system and the quality of water which it provides.

(2) This general permit is subject to the general conditions of Rule 17-555.410, F.A.C. (see reverse side) and the following specific conditions:

(a) The permittee or his engineer of record shall file with the Department upon completion of the work a copy of the plans and specifications for the system "as built".

(b) Before the system may be placed into service, a certification of construction completion by the engineer of record and a copy of satisfactory bacteriological results described in Rule 17-555.345, F.A.C., must be submitted to the appropriate office of the Department or Approved County Public Health Unit and a letter of clearance be issued.



Upon timely filing of a petition or a request for an extension of time this permit will not be effective until further Order of the Department.

When the Order (Permit) is final, Any party to the Order has the right to seek judicial review of the Order pursuant to Section 120.68, F.S., by the filing of a Notice of Appeal pursuant to Rule 9.110, Florida Rules of Appellate Procedure, with the Clerk of the Department in the Office of General Counsel, 2600 Blair Stone, Tallahassee, Florida 32399-2400; and by filing a copy of the Notice of Appeal accompanied by the applicable filing fees with the appropriate District Court of Appeal. The Notice of Appeal must be filed within thirty (30) days from the date the Final Order is filed with the Clerk of the Department.

SEWER CAPACITY PRESALE AGREEMENT

THIS AGREEMENT, made and entered into on the date set forth below, by and between Bonita Springs Water System, Inc., 11860 East Terry Street, Bonita Springs, Florida 33923 ("Service Company"), and

FOREST MERE JOINT VENTURE

26511 SOUTHERN PINES DRIVE

BONITA SPRINGS, FL 33923

("Customer")

WHEREAS, Service Company has undertaken to construct and operate a central sanitary sewer collection, transmission, treatment, and disposal system in the Bonita Springs area ("Sewer System") which has capacity available to serve Customer; and,

WHEREAS, Customer would like to receive service from the Sewer System for the following units located on its property described in Exhibit "A":

_____ mobile home	_____ condominium
_____ recreational vehicle	_____ 155 single-family
_____ commercial	_____ 120 multi-family

WHEREAS, the parties wish to enter into this Agreement in order to secure the provision of service pursuant to the terms and conditions set forth herein;

NOW, THEREFORE, in consideration of ten dollars (\$10.00) and other valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. The recitations herein are true and correct as stated.
2. The Customer hereby declares its intent to connect to the Sewer System within sixty (60) days of written notification from Service Company that capacity is available and the connection can be made. Service Company shall bear the cost of extending a sewer transmission main to a point abutting Customer's Property. Customer shall be responsible for, and bear the cost of, connection to the Sewer System's transmission main, which connection may be made by Service Company at its option.



3. Customer's obligation to connect to the Sewer System is conditioned upon Service Company providing service to the Property in the capacity set forth herein, without the payment of any connection charge, service availability charge or aid for new construction fee. Service Company has advised Customer that the failure to reserve capacity during the presale period may result in the subsequent payment of a substantial connection charge as a condition for the purchase of capacity and service.

4. Except as set forth in paragraph 8 herein, this Agreement evidences the binding obligation of both Customer and Service Company, their respective successors and assigns, for connection of existing units on the Property to the Sewer System. Customer warrants and represents that it has the authority to enter into this Agreement and to bind the Property as set forth herein.

5. Customer agrees that units on the Property shall, upon the Sewer System being made available for connection by Customer, be responsible for payment of monthly rates and charges on a take or pay basis. The rates and charges shall be those published in a tariff available from Service Company and shall be identical to rates charged to other customers in the same class of service as Customer. Monthly service charges shall include payment for treatment of all domestic wastewater introduced into the Sewer System from within the Property.

6. At Service Company's option, Customer shall convey to Service Company the on-site collection system serving the Property prior to the commencement of service from Sewer System. Such conveyance shall be by deed, bill of sale or other documents satisfactory to Service Company accompanied by appropriate easements or other property rights necessary to provide service to the Property.

7. Service Company shall provide sanitary sewer service to the Property in a manner consistent with federal, state and local regulatory requirements regarding the provision of such service. Customer shall introduce only domestic sanitary sewage from the Property into the Sewer System.

8. Service Company has advised Customer that it must achieve a minimum level of presold capacity in order to make financially feasible the provision of sanitary sewer service to Customer without payment of a connection charge. If Service Company is unable to presell that minimum capacity, and issue tax-exempt bonds of sufficient quality and amount to finance and construct the Sewer System, this Presale Agreement shall be null and void.

9. Service Company and Customer agree that this presale offer of capacity without connection charge payment, and the scope of this Agreement, apply only to existing customers within the Property receiving sewer service and those reasonably anticipated to be connected to the Sewer System within 12 months of the date that service is available, provided, however, that as to customers not connected to the Sewer System as of that date, that nevertheless monthly service fees are paid to the Sewer System on their behalf. Any customers for which monthly fees are paid for said 12 continuous months and which are not so connected to the Sewer System at the end of said 12-month period after service is so available, shall be entitled to a credit for such 12 months' payments against Service Company's connection charge in effect as of the date of actual connection.

10. It is anticipated that sewer service should be available to the property between 12 and 18 months from the time of execution hereof. For planning purposes, Customer hereby advises Service Company that it anticipates having 70 occupied units requiring sanitary sewer service as of January 1, 1992, and 205 additional occupied dwelling units requiring sanitary sewer service as of January 1, 1993.

11. This Agreement was delivered on _____, 1990 and shall constitute an offer which must be accepted within 30 days. This Agreement shall be effective upon execution.


I just received your letter of September 23. I respond as follows:

1. I am not attacking your client's credibility. I am practicing law. There is a genuine issue as to the ownership of the wastewater collection system in the Forest Mere Subdivision, and I need to know whether your client owns it or not.
2. The wastewater collection system has nothing to do with the legal description of the plant site, as referenced in your September 23 letter. The collection system is personal property at Florida law, not realty. It can, therefore, be transferred by Sheriff's Deed.
3. I see no reason to meet with your client, face-to-face, without some proof that your client has legal title to the collection system.
4. Also, I am in receipt of Rosanne Gervasi's letter of September 24 suggesting that there is no need to mediate the issue until the issue of rightful ownership is resolved. I think she is right. In short, the ball is back in your court to prove legal title and entitlement.

Copies of your letter and the PSC's letter are attached for the reference of the readers.



This will acknowledge your letter of September 18, 2002. To my surprise, on the one hand you express an interest in settling, while on the other hand you choose to attack my client's credibility. For your client's sake you need to make up your mind as to which direction you want to proceed. There is no issue as to the ownership of the waste water collection system and your attempts to cast Gistro, Inc., as a trespasser were not well received by my client. My client has instructed me to advise you that the legal description contained in that deed is the section sketched out with dark lines in the top left corner of what I have marked Exhibit "A". At the time that Sheriff's Deed was issued, that property belonged to somebody else and was of no interest to my client, therefore, there was no need to fight the deed. In addition before you label my client as a trespasser, I suggest you investigate the Sheriff's authority and/or power to even issue that deed.

Therefore, if your client is seriously interested in resolving this matter he needs to stop issuing letters of availability and you need to contact my office so we can have a face to face meeting with our clients. My client would like to do this before we had a full mediation with all parties, therefore, time is of the essence.

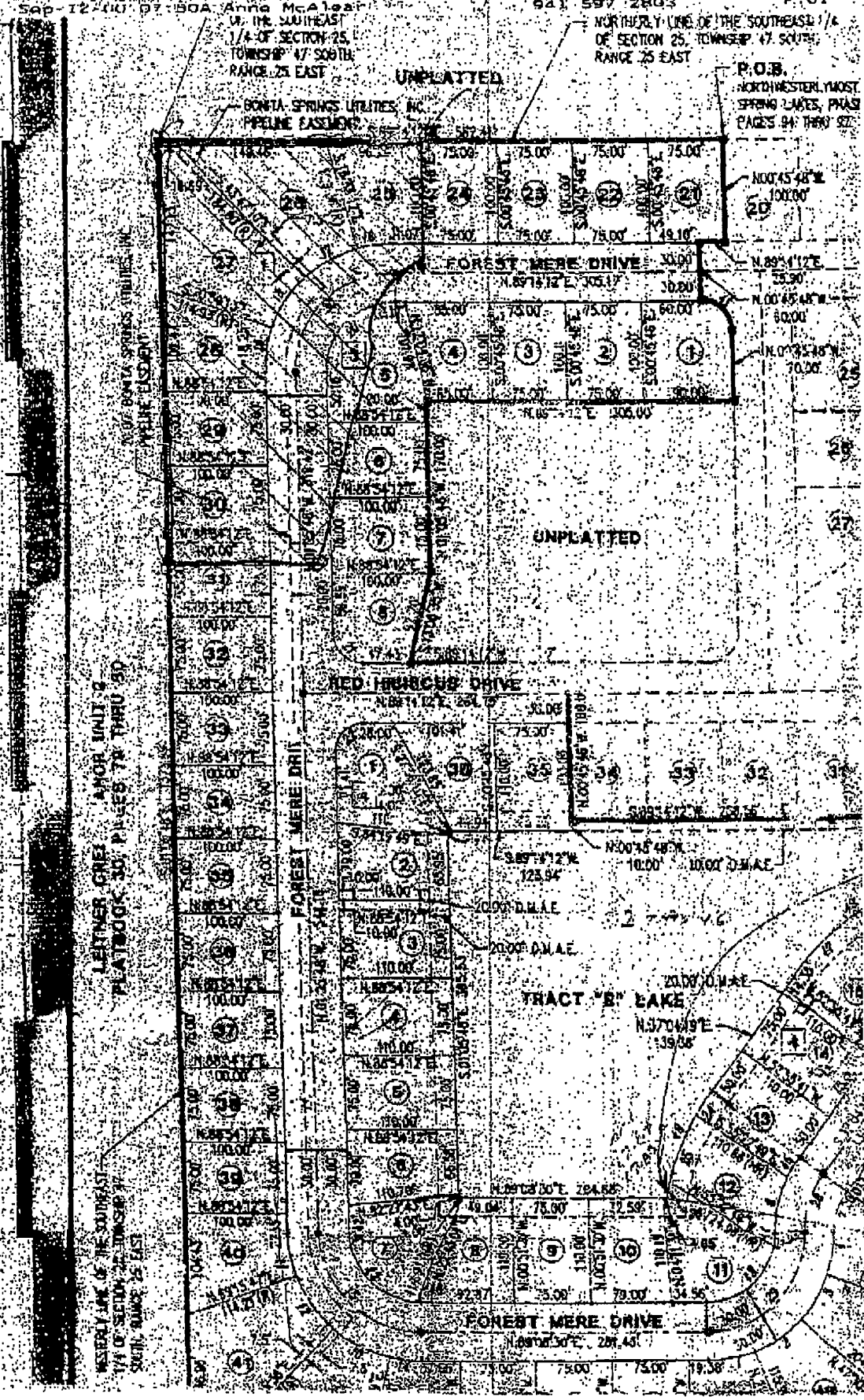

Dear Mr. Burandt:

As you know, Mr. William E. Sundstrom has provided me with a copy of a letter dated September 18, 2002, from himself to Mr. David M. Owen regarding, among other things, Gistro, Inc.'s (Gistro) authority to disconnect customers from the wastewater collection system within the Forest Mere subdivision. I am also in receipt of a copy of your letter to Mr. Owen dated September 5, 2002, on the subject, as well as of a Sheriff's Deed dated November 2, 2000, showing that the collection system at issue was sold at Public Auction to a Mr. Rolf Pfaff.

Please be advised that if Gistro has the authority to disconnect customers from the wastewater collection system within the Forest Mere subdivision, that authority is not derived from the Florida Public Service Commission's (Commission) rules, which are contained in Chapter 25-30 of the Florida Administrative Code. Since Gistro is not a utility which provides service to the public for compensation, Gistro is not bound by those rules at this time. As you are aware, your client, Mr. Holzberg, has applied with this Commission for an original certificate in the name of Gistro, Inc., to provide wastewater collection service. If that application were to be granted, including rates and charges, Gistro would at that time become authorized to charge for service and would at the same time become bound by this Commission's rules, including the rules on disconnection.

Pending a decision on Mr. Holzberg's application for certificate, the staff of this Commission has considered the idea of offering to mediate the situation involving the disconnections that have occurred and/or may occur as a result of actions taken or to be taken by your client acting as Gistro, Inc. However, the Sheriff's Deed dated November 2, 2002, which shows that the collection system was sold at Public Auction to Mr. Rolf Pfaff, calls the validity of Mr. Holzberg's application with this Commission into question. Therefore, we will postpone any offer of mediation unless Mr. Holzberg can show proof that he is indeed the rightful owner of the collection system.



The proof of ownership should be addressed to Ms. Blanca Bayo, Division of the Commission Clerk and Administrative Services, 2540 Shumard Oak Blvd., Tallahassee, Florida 32399, and Docket No. 020640-SU should be referenced on the filing. If we do not hear from either you or Mr. Holzberg regarding this matter by October 15, 2002, we will have no choice but to recommend to the Commission that Mr. Holzberg's application be denied and the docket closed.
