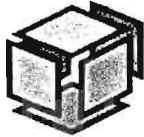

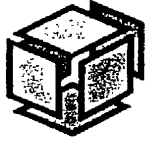

Dear Mr. Miller:

I've received your letter dated July 25th again requesting cancellation of both your IXC and ALEC certificates and asking that the 2002 Regulatory Assessment Fees be waived because the Florida Department of State, Division of Corporations, revoked your registration on September 21, 2001. Unfortunately, I cannot do that and I'm returning the forms to you.

The Regulatory Assessment Fee is mandated by statute and is applicable if a certificate is active for any one day during a calendar year. Since your certificates are still active, Structus owes the 2002 Regulatory Assessment Fee for each certificate. The alternative to a voluntary cancellation is an involuntary cancellation. In that case, I would recommend that the Commission deny your request for a voluntary cancellation for violation of Rules 25-24.474 and 25-24.820, Florida Administrative Code, and the unpaid fees would be turned over to collections.

Rules 25-24.474 and 25-24.820, Florida Administrative Code, provide that telecommunications companies requesting cancellation of their certificates either pay the current year's fees or provide a date certain they will be paid. Please respond in writing by August 20, 2002.

Dear Mr. Miller:

Ms. Angela Fondo provided me with your July 15, 2002 letter requesting cancellation of the company's IXC and ALEC certificates since you do not have any operations in Florida.

The effective date of a voluntary cancellation is the date the Commission received the company's request for cancellation. In this case, the Commission received your request on July 19, 2002, therefore, the company will only owe the 2002 Regulatory Assessment Fee (RAF). The 2002 RAF return forms for both certificates are enclosed.

The Commission's cancellation rules provide that telecommunications companies requesting cancellation must either pay the current year's RAF or provide a date certain it will be paid. Once the 2002 RAF is paid for each certificate (minimum \$50 each certificate) or the company provides a date certain the fees will be paid (due by January 30, 2003), then the Commission will voluntarily cancel the certificates with an effective date of July 19, 2002.
