Re: Docket No. 020982-WS; Application of Mad Hatter Utility, Inc. for amendment of water and wastewater certificates in Pasco County, FL

Dear Mr. Deterding:

The filing in this docket has been reviewed for compliance with minimum filing requirements. The following deficiencies exist:

1. Exhibit F, the Affidavit of Noticing the customers and property owners, is not dated, either by the affiant or the notary.
2. Exhibit G, the Notice of Application published in the newspaper, has not been received.
3. Numbers and dates of permits from the DEP for the system(s) proposed to be constructed (see Rule 25-30.036(3)(k), Florida Administrative Code).

In addition, there are other items that will need correction or additional information.

1. The filing fee is insufficient. Rule 25-30.020, (2)(b)(2), F.A.C., addresses the filing fee requirements for areas with the capacity to serve from 101 to 200 ERCs. This rule requires a \$200 filing fee for each water and each wastewater application for extension, and a \$200 filing fee for each water and each wastewater application for deletion. The utility's application on page 4 states that the area to be deleted involves 187 lots, and the number of lots to be added is 174. We would equate one lot to one ERC for filing fee purposes, which means the filing fee should be \$800.
2. Exhibit B, which is part of the Territorial Transfer Agreement between Mad Hatter Utility, Inc. and Pasco County, has a map included, which apparently is the apex property. The map is essentially not readable. If there is a better copy, please provide one.


