Intervenors/Appellants, the Citizens of the State of Florida, through the Office of Public Counsel, pursuant to Rule 9.200(a)(3), Florida Rules of Appellate Procedure, direct Ms. Blanca S. Bayó, Director, Division of the Commission Clerk and Administrative Services, to include the following items in the original record described in rule 9.200(a)(1):

PRELIMINARY STATEMENT

The Citizens filed a Notice of Administrative Appeal of Order No. 02-1199-PAA-EI on October 3, 2002. The docket in which the order was issued, however, Docket No. 020233-EI, is a continuation of three precursor dockets. Phase 1 of Docket No. 000824-EI dealt with Florida Power Corporation's participation in the GridFlorida regional transmission organization ("RTO"). Additionally, Phase 1 of Docket No. 001148-EI dealt with Florida Power & Light Company's participation in the RTO. And Docket No. 010577-EI dealt exclusively with Tampa Electric Company's participation in the RTO. These three dockets were combined (although not consolidated) for purposes of reviewing the three GridFlorida Companies' petitions for approval of the RTO. Since most of the RTO filings were made in all three dockets, there are many duplicates among the three docket files.

DOCUMENT HUMBER-DATE

To avoid having so many duplicates filed with the Supreme Court of Florida, these directions treat the Tampa Electric docket, Docket No. 010577-EI, as the primary GridFlorida docket until Docket No. 020233-EI came into being in March, 2002.
