Staff is concerned due to the fact that we are recommending (1) a reduction in water revenues and rates and (2) a refund of temporary rates in the amount of \$69,065, due to an illegal rate increase. Although these temporary rates are currently held subject to refund, there is no security to protect this refund.

Further, we were informed that the utility has been foreclosed upon approximately one month ago; however, we do not have any documentation to confirm this has occurred.


