Dear Mr. Hintsala:

The Commission received your request for cancellation of United Payphone Owners, LLP's pay telephone certificate. Rule 25-24.514(2)(a) and (b), Florida Administrative Code, provides that when a company requests cancellation, it must include its intent and date to pay the Regulatory Assessment Fee (RAF) and state why its certificate is proposed to be cancelled. A copy of the rule is enclosed.

The effective date of a voluntary cancellation is the date that the Commission received a company's request for cancellation, which, in this case was September 23, 2002. This means the company will owe the 2002 RAF, even if the company is no longer in business or, in fact, never went into business. The 2002 RAF return form is enclosed in case the company chooses to go ahead and pay the RAF.

As soon as the company complies with Rule 25-24.514(2)(a) and (b), Florida Administrative Code, a docket will be established to cancel the company's certificate. Please respond in writing by October 21, 2002. In the meantime, if you have any questions, just let me know. **25-24.514 Cancellation of a Certificate.**

- (1) The Commission may cancel a company's certificate for any of the following reasons:
- (a) Violation of the terms and conditions under which the authority was originally granted;
  - (b) Violation of Commission rules or orders;
  - (c) Violation of Florida Statutes; or,
  - (d) Failure to provide service for a period of six (6) months.

(2) If a certificated company desires to cancel its certificate, it shall request cancellation from the Commission in writing and shall provide the following with its request.

- (a) Statement of intent and date to pay Regulatory Assessment Fee.
- (b) Statement of why the certificate is proposed to be cancelled.

(3) Cancellation of a certificate shall be ordered subject to the holder providing the information required by subsection (2).


