The Commission received your request for cancellation of United Payphone Owners, LLP's pay telephone certificate. Rule 25-24.514(2)(a) and (b), Florida Administrative Code, provides that when a company requests cancellation, it must include its intent and date to pay the Regulatory Assessment Fee (RAF) and state why its certificate is proposed to be cancelled. - (a) Statement of intent and date to pay Regulatory Assessment Fee.
- (b) Statement of why the certificate is proposed to be cancelled.
- (3) Cancellation of a certificate shall be ordered subject to the holder providing the information required by subsection (2).
