Dear Mr. Fordham,

This letter is to advise you of recent developments related to AT&T Communications of the Southern States, LLC's (AT&T's) complaint against BellSouth Telecommunications, Inc. (BellSouth) regarding BellSouth's Switched Access Discount Tariffs. As noted in AT&T's Amended Petition, filed September 13, 2002, BellSouth had withdrawn its Switched Access Discount Tariff in Tennessee. Since that time, BellSouth has filed another version of that tariff. On October 21, 2002, the Tennessee Regulatory Authority (TRA) voted to suspend BellSouth's latest switched access discount filing and has set the matter for hearing. There is as yet no order from the TRA reflecting the TRA's decision; however, it is AT&T's understanding that the transcript of the proceedings will be available on October 25, 2002. AT&T will supply the transcript as soon as it is available. This information was conveyed to Mr. Michael Barrett, one of the members of the Florida Commission Staff assigned to this case, as well as to Counsel for BellSouth by telephone late yesterday afternoon.
