

CARGILL FERTILIZER, INC.'S RESPONSE TO TAMPA ELECTRIC COMPANY'S MOTION TO HOLD PROCEDURAL SCHEDULE IN ABEYANCE

Cargill Fertilizer, Inc. (Cargill), pursuant to rule 28-106.204, Florida Administrative Code, files this Response to Tampa Electric Company's (TECo) Motion to Abate the Procedural Schedule.

1. Cargill has no objection to extending all currently scheduled procedural dates by 120 days from the date the motion is approved. TECo agrees that during the suspension of procedural dates, the self-service wheeling (SSW) program will remain in place pursuant to Commission Order No. PSC-02-1451-PCO-EQ.

2. TECo declines to mediate a resolution of this proceeding¹ until the Federal Energy Regulatory Commission (FERC) acts upon TECo's request to restrict the ancillary and services provisions of its Open Access Transmission Tariff on file with FERC. The restrictions are to ensure that Cargill receives back-up service only from TECo. Cargill will support TECo's request in this regard, although its support should not be construed to be a concession that the Florida Commission lacks authority to compel retail SSW. As Cargill stated in correspondence to Staff member, Michael Haff, it is this Commission that has statutory authority over retail SSW and that jurisdiction has not been ceded to the FERC.

¹ Cargill requested mediation of this matter on October 9th and again on October 16th.

3. Cargill respectfully suggests that should FERC act upon TECo's tariff amendment before the conclusion of the 120-day procedural abatement that the parties be authorized to proceed with mediation to resolve the disputed issues in this matter.

4. Further, to the extent it becomes necessary to reschedule the hearing in this matter, Cargill requests that such rescheduling provide sufficient time for Cargill to receive and review all responses to discovery served on TECo.² Cargill further respectfully requests that it be protected against any hearing date during the first three weeks in June 2003 as Cargill's counsel has conflicting commitments during that time period.
