Re: Corporate Dissolution Of Easton Telecom, Inc. and American Long Lines, Inc.

Dear Sir or Madam:

The purpose of this letter is to formally notify the Commission of the corporate dissolution and termination of existence of Easton Telecom, Inc. ("Easton") and American Long Lines, Inc. ("ALL") (each of which was previously authorized to provide certain telecommunications services in the State of Florida) pursuant to the order of the United States Bankruptcy Court for the Southern District of New York, on September 6, 2002, approving the Third Amended Plan of Reorganization of Teligent, Inc. ("Plan"), the former ultimate corporate parent of Easton and ALL.¹ Neither Easton nor ALL had any customers, assets or operations at the time of their dissolution and termination of existence.

Consummation of the Plan occurred on September 12, 2002 in accordance with the Court's order approving the Plan. Article VI(A) of the Plan provided that subsequent to its consummation, each of the debtors, including Easton and ALL, but excluding Reorganized Teligent (i.e., Teligent, Inc., Teligent Services, Inc. and Teligent of Virginia, Inc.) shall be deemed to have dissolved or otherwise terminated its existence. Reorganized Teligent has notified the Delaware Secretary of State as well as the comparable office in this State to update its records to reflect such dissolution and termination of existence of these entities effective September 13, 2002.

Please note that neither the Bankruptcy Court's action in approving the Plan nor the resultant dissolution of Easton and ALL effects the ongoing existence of or authorizations granted to any

¹ The names of Easton and ALL were changed to Winston Shell Corp. and Xandu Shell Corp., respectively, in order that the acquirers of their assets in the bankruptcy would be able to use the same general name in the conduct of their ongoing telecommunications businesses.


