Re: Approval of Amendment to the Interconnection, Unbundling, Resale, and Collocation Agreement Negotiated by BellSouth Telecommunications, Inc. ("BellSouth") and WAMNet Communications, Inc. (n/k/a Airface Communications, Inc.) pursuant to Sections 251, 252 and 271 of the Telecommunications Act of 1996

Dear Mrs. Bayo:

Pursuant to section 252(e) of the Telecommunications Act of 1996, BellSouth and WAMNet Communications, Inc. (n/k/a Airface Communications, Inc.) are submitting to the Florida Public Service Commission an amendment to their negotiated agreement for the interconnection of their networks, the unbundling of specific network elements offered by BellSouth and the resale of BellSouth's telecommunications services to WAMNet Communications, Inc. (n/k/a Airface Communications, Inc.). The initial agreement between the companies was filed in FPSC Docket No. 011216-TP.

Pursuant to section 252(e) of the Act, the Commission is charged with approving or rejecting this amendment to the negotiated agreement between BellSouth and WAMNet Communications, Inc. (n/k/a Airface Communications, Inc.) within 90 days of its submission. The Act provides that the Commission may only reject such an agreement if it finds that the agreement or any portion of the agreement discriminates against a telecommunications carrier not a party to the agreement or the implementation of the agreement or any portion of the agreement is not consistent with the public interest, convenience and necessity. Both parties agree that neither of these reasons exists as to the agreement they have negotiated and therefore, as such this amendment should be deemed effective by operation of law on January 23, 2003.

**AMENDMENT  
TO THE  
INTERCONNECTION AGREEMENT BETWEEN  
WAMNET COMMUNICATIONS, INC. AND  
BELLSOUTH TELECOMMUNICATIONS, INC.  
DATED JULY 23, 2001**

Pursuant to this Amendment to the Interconnection Agreement between WAMnet Communications, Inc. and BellSouth Telecommunications, Inc. ("The Amendment"), WAMnet Communications, Inc. ("WAMnet") and BellSouth Telecommunications, Inc. ("BellSouth") hereinafter referred to collectively as the "Parties," hereby agree to amend that certain Interconnection Agreement between the Parties dated July 23, 2001 Interconnection Agreement").

WHEREAS, WAMnet has changed the name of said business to Airface Communications, Inc., a Florida corporation.

WHEREAS, the Parties desire that the Interconnection Agreement be amended to reflect the correct corporate entity name.

NOW THEREFORE, in consideration of the mutual promises and covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties hereby covenant and agree as follows:

1. The name of WAMnet in the Interconnection Agreement is hereby deleted throughout the Interconnection Agreement and replaced with Airface Communications, Inc. ("Airface").
2. All of the other provisions of the Interconnection Agreement, dated July 23, 2001 shall remain in full force and effect.
3. Either or both of the Parties is authorized to submit this Amendment to each Public Service Commission for approval subject to Section 252(e) of the Federal Telecommunications Act of 1996.
