On Tuesday afternoon, October 22, 2002, I received a telephone call from Ms. Michelle Lorenzo with the Office of Representative Marco Rubio, relating to the above noted docket. Ms. Lorenzo indicated to me that Representative Rubio's constituents had been calling regarding BellSouth's notice to Supra customers that they needed to select a new carrier within a 14-day period. Ms. Lorenzo indicated that the Representative did not believe a 14-day notice was adequate and that the customers should be given at least 30 days notice. I responded that I was sympathetic to these concerns but that the Commission would be voting on related issues at an upcoming Agenda conference and, therefore, I could not discuss the issues further.

In the abundance of caution, I request that this memorandum, which states the substance of the communication I received on October 22, 2002, and my response, be placed in the record of this docket and disseminated to all the parties.
