ENCLOSED IS A CHECK IN THE AMOUNT OF \$259.31 AND THE APPLICABLE COMPLETED REGULATORY ASSESSMENT FEE DOCUMENT ON BEHALF OF LONESTAR TELCOM, INC.

LONESTAR TELCOM, INC. DEFINITELY WISHES TO KEEP ITS CERTIFICATE ACTIVE AND IN COMPLIANCE WITH COMMISSION RULES WE FEEL IT MAY HAVE GONE TO THE INCORRECT ADDRESS BECAUSE THE PARTNERS SPLIT AND THE REPORT WAS NOT FORWARDED TO US. WE HAVE TAKEN STEPS TO PREVENT FUTURE LATE PAYMENTS OF THE REGULATORY ASSESSMENT FEES.

WE HAVE MADE THIS CHANGE ON THE DOCUMENT AND ALSO I NOTIFIED BARBARA BAILEY OF YOUR OPR STAFF AND SHE ARRANGED FOR THE CHANGE TO BE MADE THERE AS WELL.

THE COMPANY AGREES TO WAIVE ANY OBJECTION TO THE ADMINISTRATIVE CANCELLATION OF ITS CERTIFICATE SHOULD LONESTAR FAIL TO PAY IN ACCORDANCE WITH ITS SETTLEMENT OFFER.
