Dear Ms. Bayo:

On June 17, 2002, ACSI Local Switched Services, Inc., d/b/a e.spire and American Communication Services of Jacksonville, Inc., d/b/a e.spire (together, the "e.spire Operating Entities"); and Xspedius Management Co. Switched Services, LLC and Xspedius Management Co. of Jacksonville, LLC (together, the "Xspedius Operating Entities"), by their attorneys, filed an Application with the Florida Public Service Commission ("Commission") regarding the transfer of substantially all of the assets, including the customer contracts and Certificates of the e.spire Operating Entities to the Xspedius Operating Entities, and the discontinuance of telecommunications service by the e.spire Operating Entities in the State of Florida. This Application was approved by the Commission on August 19, 2002, in Docket No. 020535-TP. This letter is to advise the Commission that the transaction that was the subject of the Application is complete. The Xspedius Operating Entities currently are serving the former customers of the e.spire Operating Entities in Florida. At this time, the e.spire Operating Entities no longer are providing telecommunications service to customers in Florida, and understand that their Certificates have been transferred accordingly.
