I have outlined below the answers to each of the questions from your October 14, 2002 letter. These follow the format of the questions raised.

## **Deficiencies**

1. Exhibit F, the Affidavit of Noticing the customers and property owners, is not dated, either by the affiant or the notary.

Response - Attached hereto is a copy of a revised notice with the appropriate dating contained therein.

2. Exhibit G, the Notice of Application published in the newspaper, has not been received.

Response - The Notice of Publication was sent to the Commission Clerk or September 27, 2002. I am attaching a copy for your ready reference.

3. Numbers and dates of permits from the DEP for the system(s) proposed to be constructed (see Rule 25-30.036(3)(k), Florida Administrative Code).

Response - No DEP permits have yet been applied for, much less proposed for construction at this time. It is unclear at this time the exact configuration of the properties exchanged between the two entities and as such, no plans for location of facilities have been made. However, attached hereto is a copy of a map showing the location of the "Apex" property which is proposed to be included within Mad Hatter's territory. It also shows the location of the water and wastewater lines, color coded for your ready reference. As you can see, there are facilities immediately adjacent to this territory to allow easy access and availability of service once the property is developed.
