On April 30, 2001 the Florida Public Service Commission's Division of Auditing and Safety initiated an audit of AT&T's 1998-1999 Regulatory Assessment Fee payments. During the course of this audit, AT&T responded to several document requests and requested that certain materials be held in a temporary confidential status, pursuant to Rule 25-22.06(3)(a). On October 26, 2002, the auditor completed the exit conference and provided its list of audit work papers. These materials are considered confidential business information and are held in a temporary confidential status.

Pursuant to Rule 25-22.06(5), AT&T is now filing a Claim for Confidential Classification because the information contained in the material provided contains business information that is considered confidential and proprietary to AT&T and could cause competitive harm if disclosed. Additionally, this information is valuable and AT&T strives to keep it from being disclosed to the public. Pursuant to Sections 364.183 and 364.24 365.183, Florida Statutes, such information is classified as proprietary confidential business information. Accordingly, it should be held exempt from the public disclosure requirements of Section 119.07, Florida Statutes.

Attachment A is a list that identifies the location of the information designated by AT&T as confidential. Attachment B contains two redacted copies of the proprietary information.
