Dear Mrs. Bayo:

Pursuant the Telecommunications Act of 1996, BellSouth and DSL Internet Corporation d/b/a DSLi are submitting to the Florida Public Service Commission their negotiated agreement for the interconnection, unbundling of specific network elements, collocation of BellSouth networks, and resale of their telecommunications services to DSL Internet Corporation d/b/a DSLi. The agreement was negotiated pursuant to sections 251,252 and 271 of the Act. The initial agreement between the companies was filed in FPSC Docket No. 020170-TP.

Pursuant to section 252(e) of the Act, the Commission is charged with approving or rejecting this amendment to the negotiated agreement between BellSouth and DSL Internet Corporation d/b/a DSLi within 90 days of its submission. The Act provides that the Commission may only reject such an amendment if it finds that the amendment, or any portion of the amendment, discriminates against a telecommunications carrier not a party to the amendment or if the implementation of the amendment or any portion of the amendment is not consistent with the public interest, convenience and necessity. Both parties agree that neither of these reasons exists as to the amendment they have negotiated. Therefore, this amendment should be deemed effective by operation of law on February 11, 2003.

AMENDMENT TO THE AGREEMENT BETWEE* DSL INTERNET CORPORATION D/B/A DSLI AND BELLSOUTH TELECOMMUNICATIONS, INC. DATED NOVEMBER 13, 2001

.

Pursuant to this Amendment, (the "Amendment") DSL Internet Corporation d/b/a DSLi ("DSLi") and BellSouth Telecommunications, Inc. ("BellSouth"), hereinafter referred to collectively as the "Parties", hereby agree to amend that certain Interconnection Agreement between the Parties dated November 13, 2001 ("Agreement").

NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, DSLi and BellSouth hereby covenant and agree as follows:

1. The Parties agree to delete General Terms and Conditions, Section 24.3, in its entirety in the interconnection agreement dated November 13, 2001 and replace it with the following:

"Notwithstanding the foregoing, BellSouth may provide DSLi notice via Internet posting of price changes and changes to the terms and conditions of services available for resale per Commission Orders. BellSouth will also post changes to business processes and polices, notices of new service offerings, and changes to service offerings not requiring an amendment to this Agreement, notices required to be posted to BellSouth's website, and any other information of general applicability to CLECs."

- 2. All other provisions of the Interconnection Agreement, dated November 13, 2001, shall remain in full force and effect.
- 3. Either or both of the Parties are authorized to submit this Amendment to the appropriate state Commissions for approval subject to section 252(e) of the Federal Telecommunications Act of 1996.
