

In support of this motion, BellSouth states the following:

1. Pursuant to the Order Establishing Procedure, issued on September 23, 2002, Order No. PSC-02-1295-PCO-TP, Rebuttal Testimony and Prehearing Statements are due to be filed on November 19, 2002.

2. Because of previous work commitments, including filings and hearings in other states, BellSouth needs additional time to file Rebuttal Testimony and Prehearing Statements in the captioned dockets.

3. The Parties would not be prejudiced by a six (6) day extension of time. Further, BellSouth would not object to all parties receiving a similar extension.


