
Dear Ms. Bayo:



The purpose of this letter is to give formal notice of Pan American Telecom's intention to dismiss its pending petition for PSC approval of its Interconnection Agreement with Bellsouth. We are currently preparing to give notice to all current Pan American customers of a change in service, and, are ready to coordinate with Bellsouth to ensure that all Pan American customers are treated correctly. Pan American Telecom also requests that all debits and credits between the two companies be accounted for at this time.
