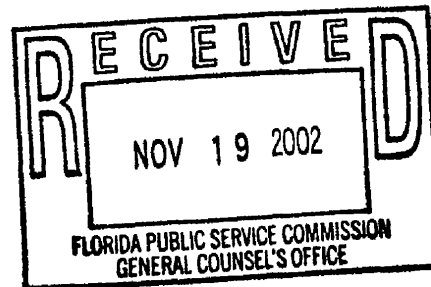




**CITY OF PALM COAST'S NOTICE OF WAIVER RELATING TO
